**1. Case No. 2159 – 233 Alta Ave**

Application of Charles Cottle, owner, represented by Kyle Fox, Kyle Fox Design, requesting the following variance(s) on the property located at 233 Alta Ave, CB 4024 BLK 151 LOT W 40 FT OF 18 & E 25 FT OF 19 ARB 18B & 19A, zoned SF-B:

- 1) a parking pad in the front yard setback; and
- 2) an impervious surface cover of 37% within the front yard setback instead of the ~~35~~ 30% maximum allowed by code.

~~Application of David and Amy Doyle, owners, represented by Richard Garison, Shelly Home Company, requesting the following variance(s) on the property located at 318 Blue Bonnet Blvd, CB 5571A BLK 9 LOT 3-4 W 1/2 OF 5, zoned SF-A:~~

- ~~1) a side yard (east) setback of 7 ft 1 in for the main structure instead of the 10-ft minimum required by code; and~~
- ~~2) a garage attached to the main structure on a 62.5-ft wide lot instead of the lot width (65+ ft) permitted by code.~~

**3. 4. Case No. 2162 – 602 Ogden Ln – Applicant requested postponement due to City Council's adoption of the Residential Design Standards amendments on 1/23/12**

~~Application of Laurie Saunders, owner, represented by Ryan Schmidt, Ryan Schmidt Design, requesting the following variance(s) on the property located at 602 Ogden Ln, CB 4024 BLK 111 LOT E 75 FT OF 1 & E 75 FT OF 2 /H, zoned SF-B:~~

- ~~1) a front yard setback of 24 ft 1 in instead of the 25-ft minimum required by code;~~
- ~~2) a rear setback of 28 ft 3 in instead of the 35-ft minimum required by code;~~

- ~~3) a wall plane length of 39 ft 5 in (on the first floor of the east elevation) instead of the 35 ft maximum permitted by code without a minimum 3 ft offset;~~
- ~~4) a wall plane length of 36 ft 6 in (on the second floor of the east elevation) instead of the 35 ft maximum permitted by code without a minimum 3 ft offset;~~
- ~~5) a wall plane length of 47 ft 7 in (on the first floor of the west elevation) instead of the 35 ft maximum permitted by code without a minimum 3 ft offset;~~
- ~~6) a wall plane length of 36 ft 9 in (on the second floor of the west elevation) instead of the 35 ft maximum permitted by code without a minimum 3 ft offset;~~
- ~~7) a height within the first 15 ft of the main structure of 28 ft instead of the maximum 24 ft permitted by code;~~
- ~~8) an overall height of 30 ft 11 in instead of the maximum 28 ft permitted by code; and~~
- ~~9) a 3 ft 2 in separation distance of the detached accessory structure from the main structure instead of the 10 ft minimum separation required by code.~~
