


### **SUMMARY**



The applicant, owner of 740 Tuxedo, has requested the City close, vacate, abandon, and sell a portion of alley that abuts the west side of the property.

### **EXISTING CONDITIONS**







15ft wide alley

2,212 sq ft(.05 acre tract)

### BACKGROUND



The commission considered the request at their February 07, 2022 meeting and tabled the case to allow applicant to communicate with the adjacent neighbor regarding the recent zoning code amendment that would exempt future improvements from the looming standard on the east side that adjoins the alley in question.

### POLICY ANALYSIS

- Sect. 16-105: Closure, vacation & abandonment of ROW
  - (d)(1) & (3) Planning and Zoning Commission recommendation needed for City Council consideration
  - (e)Petitioner to provide fair market value of the ROW to be abandoned
- Sect. 16-101: General Provisions
  - (g) Fair market value Option to rely on an average price per square foot per BCAD market values or require an independent professional appraisal by a jointly selected appraiser.
    - Owner has agreed to average price per square foot per BCAD market values
    - \$21.43 per sq ft = \$44,394.69

- All public meetings governed by Texas
   Open Meeting Act
  - Establishes legal requirements
- City Council adopted own rules of procedure & public testimony policy
- Council recommended boards & commission to adopt similar rules for meetings

### **BACKGROUND**



- Rules of Procedure Purpose
  - Ensure meetings:
    - Conduct business of City effectively
    - Members of public heard in fair, impartial & respectful manner
    - Open to all viewpoints yet free from abusive, distracting or intimidating behavior
    - Decorum understood by attendees





#### City Council:

- 2006 Rules of Procedure Governing Meetings adopted
- 2007 to 2010 3 updates
- July 26, 2021 Latest rules adopted
  - Resolution # 2021R 133
  - Policy encouraged boards & commissions to adopt these rules as applicable

# POLICY ANALYSIS



- Adoption of consistent meeting rules standardizes proceedings
- Public's right to address Board defined to:
  - Alamo Heights citizens & business owners
- Comment topic limited to only agenda item signed up for

# POLICY ANALYSIS



- Formalize current notification process
  - Agenda packet posted on City website
- Appropriate etiquette of audio/visual recording devices
  - Designated location for larger devices
