Case No. 2476 – 132 Grant Ave

Application of Grant Winston, applicant, representing Bob McClane, owner, requesting the following variance(s) in order to install a generator at the rear of the property on the property located at **CB 4024 BLK 11 LOT 59**, also known as **132 Grant Ave**, zoned SF-A:

1. A proposed 1ft side yard setback instead of the minimum 3ft required per Section 3-15 and
2. A proposed 1ft rear yard setback instead of the minimum 3ft required per Section 3-16 of the City's Zoning Code. (Tabled from June 3, 2026 regular meeting) **Withdrawn by applicant. No action taken.**

Case No. 2477 – 514 Patterson Ave

Application of Cameron Smith of Smithdish Architecture, applicant, representing Mary Herff, owner, requesting the following self-identified variance(s) in order to install a porte-cochère on the property located at **CB 4024 BLK 21 LOT 2A AND N 31.6 FT of 3A**, also known as **514 Patterson Ave**, zoned SF-A:

1. The attached porte-cochère is located to the front of the front façade of the main structure instead of being set back eighteen (18) feet from the front façade as required per Section 3-21 of the City's Zoning Code. **Variance approved as requested.**
