Public hearing, consideration, and action regarding a request to replat the property identified as LOT E 83.3 FT OF 5, BLK 199, CB 4024, also known as 740 Tuxedo Ave, and a portion of public right-of-way, approximately 2,212 sq ft (0.05 acre tract) of the 15ft wide alley that adjoins the western side of the subject property.

Ms. Hernandez presented the case. She informed that the applicants had been before the Commission previously for the purchase of a portion of the right of way from the City. She went on to say that the proposed replat was a condition of the sale and, as proposed, met all requirements of code. Richard Y'Barbo was present via teleconference.

Commissioner Cuffy opened the public hearing at 5:39 p.m. but no one was present to speak with interest in the case so the public hearing was closed.

Commissioner Feldman asked about the effect of the replat on looming requirements for the adjacent property owner and Ms. Hernandez responded.

Mr. Y'Barbo addressed the Board and spoke regarding future plans for the alley. Commissioner Grable asked the applicant about the effect of the replat on his next-door neighbor. Mr. Y'Barbo responded that he had talked with the neighbor about the replat and the neighbor had given his support for the replat.

Commissioner Dawley moved to recommend approval of the replat as requested. The motion was seconded by Commissioner Honigblum.
