City of Alamo Heights, Texas SOLICITOR'S PERMIT

1. License must be prominently displayed on outer clothing while soliciting
2. Prohibited from personal contact, leaving flyers, entering or remaining on property for residents on the "No Visit" list or displaying a yard sign or door notice reading "No Soliciting" or "No Solicitors"
3. Must utilize front or main entrance of a residence ONLY.
4. Do not attach handbill/flyers to signs, poles, structures in the public right-of-way or on privately owned property in a manner that causes damage to the property.
5. Must identify to the Police when requested
6. Prohibited from removing yard signs, door/entrance signs posted for "No Soliciting.
7. Commercial Solicitors are prohibited from soliciting for any purpose other than that set out in the application.
8. Permitted hours: 1/2 hr. after sunrise to 1/2 hr. before sunset
9. Persons under age 18 prohibited from soliciting in a public right-of-way
10. Persons prohibited from entering or remaining in the traveled portion of roadway
11. No soliciting in a public right-of-way within 1000 ft. of school between 7:30 a.m. and 4:30 p.m. On days when a school is in session
