Stage 3 Water Restrictions in Effect

The City of Alamo Heights went into Stage 3 Water restrictions effective June 17, 2022, as mandated by order of the Edwards Aquifer Authority.

Landscaping Watering (using automatic or manual irrigation systems) is permitted **only once EVERY OTHER week** between the hours of 7:00 a.m. to 11:00 a.m. and 7:00 p.m. to 11:00 p.m. The last number of your address determines what day you are able to water. You may water once during the week of July 4th and it is a non-watering week during the week of July 11th.

You may use drip irrigation, soaker hose, or bucket (5-gallon or less container) during any day of the week but only between the hours of 7:00 a.m. to 11:00 a.m. and 7:00p.m. to 11:00 p.m. A hand-held hose may be used any day of the week at any time.

Aquifer Water Levels

The Edwards Aquifer Authority website, www.edwardsaquifer.org, is a great resource in understanding the water level readings as well as the water usage restrictions when in drought conditions. The EAA monitors the water levels of the San Antonio and Uvalde Pools. These levels are measured around the clock utilizing different devices within the monitoring wells throughout the aquifer. The water level data regulates the criteria for determining when to impose the groundwater withdrawal restrictions for aquifer users, such as Alamo Heights, during droughts. The ten-day average triggers the water restriction stages.

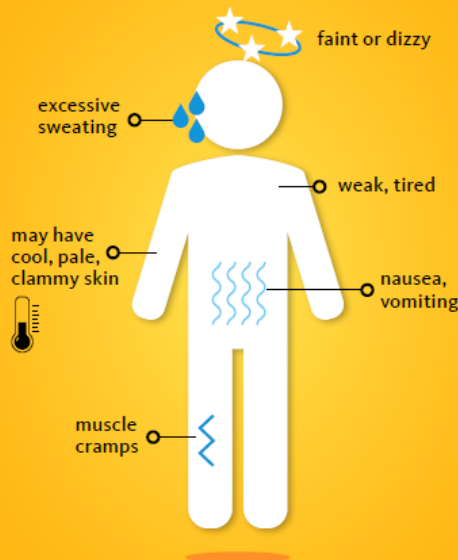

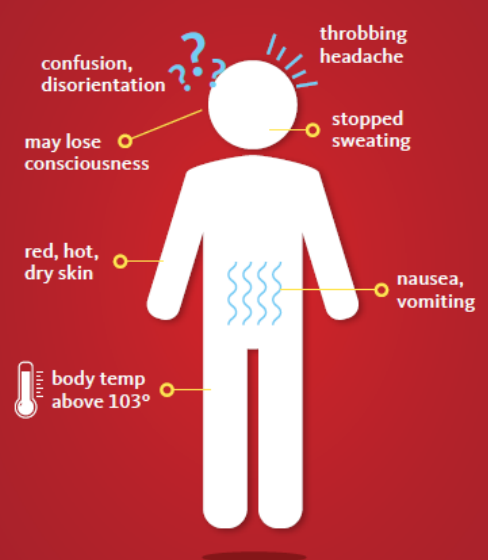
Heat Exhaustion
