

ORDINANCE NO. 2204

ORDINANCE CANVASSING ELECTION RETURNS AND DECLARING THE RESULTS OF THE MAY 6, 2023, GENERAL ELECTION TO ELECT A MAYOR AND TWO COUNCIL MEMBERS FOR PLACES 1 AND 2 FOR A TWO-YEAR TERM; AND DECLARING THE RESULTS OF SAID ELECTION IN THE CITY OF ALAMO HEIGHTS, TEXAS; AND SETTING AN EFFECTIVE DATE.

WHEREAS, the City Council of the **CITY OF ALAMO HEIGHTS, TEXAS** (the "*City*") on February 13, 2023, ordered a General Election to elect a Mayor and two Council Members to fill Places 1 and 2, hereinafter stated (the "*Election*"); and

WHEREAS, the City Council has reviewed and investigated all matters pertaining to this election, including the ordering, notices, election officers, holding, and returns thereof; and

WHEREAS, the City Council hereby canvasses the returns of this election, at which there were submitted to all resident, qualified electors of the City for their action thereupon, the following are the election results for the election of City Council;

WHEREAS, the official returns show that there were 3,401 votes cast; and

WHEREAS, the following candidates received the number of votes set opposite their respective names, to wit:

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALAMO HEIGHTS, TEXAS:

SECTION 1. It is found, determined and declared by the City Council that said election was duly called; that notice of said election was given in accordance with law, and that said election was held in accordance with law; and that Karl P. Baker was duly elected to Councilmember, Place 2, Bobby Rosenthal was duly elected as Mayor (unopposed), and Lawson Jessee was duly elected to Councilmember, Place 1 (unopposed). Said above named parties are hereby declared duly elected to said respective offices, subject to the taking of the oath of office as provided by the laws of the State of Texas.


SECTION 2. The returns of the Election, properly certified, were made and returned in the manner required by the laws of the State of Texas and of the United States of America and the order calling the election.
