SCHEDULE OF DEVELOPMENT FEES

All fees are subject to change at the discretion of the City Council.

All application fees for a submission to any Board/Commission shall be due upon receipt of application.

CONTRACTOR REGISTRATION

General Contractor: \$100.00 annually

Tradesman: \$25.00 annually

PLAN REVIEWS (in addition to all building permit fees)

Commercial & New Construction Residential

Fee: 50% of the calculated building permit fee
Residential Interior Remodel Fee: The lesser of
\$250 or 50% of the calculated building permit fee
Preliminary Plan Review/Meetings: \$75 after the

first meeting.

FIRE PERMITS

Fees are based on the scope of work of each specific permit but not be less than \$65.00 (contact the Fire Department for specific fire permit fees).

DEMOLITION & MOVES

Fees are based on the total valuation of demolition (see specific Permit Fees) plus a \$500.00 refundable clean-up deposit required for demolition of main structures.

PERMIT RENEWALS & EXTENSIONS:

(Maximum 90 calendar days from original expiration date) **Prior to expiration:** \$25 administrative fee **After expiration:** \$25 administrative fee +\$250 penalty fee

INSPECTIONS

Fee for both partial inspections and re-inspections is \$141 for building and \$65 for trades.

TRADE & COMMERCIAL BUILDING PERMITS

Fees for all permits including building, mechanical, landscaping, electrical, plumbing, sewer, and gas permits, but excluding fire, are based on the total value of the project.

\$10,000,000 and over	\$58,000 + 0.5% of the amount over \$10,000,001

RESIDENTIAL BUILDING PERMITS

*Interior Demolition Permit

Fees are based on only the total square footage of the project that requires an inspection. Square feet receiving painting, flooring, or cabinetry changes alone are not considered within the calculation.
